Motion by E. Bruss, seconded by J. Sroka, "to approve the permit for home and garage remodel at 87 N. Lake St. with the condition of no roof on the front deck," Motion passed

#### **Old Business:**

- 1. Short-Term Rentals & Public Hearing: M. Simon discussed the language of the ordinance that the attorney had recommended, and stated that she had added the language for a maximum 10 percent (10%) limit of the total houses in the village, that had previously been approved by the commission. The Public Hearing will be tomorrow night April 24<sup>th</sup> at 6:00 PM., followed by the Village Council review/approval at their Special Meeting.
- 2. <u>Proposed Zoning Amendments to Village Council</u>: After a discussion about fences, it was decided to delete the phrase "on the property/lot line or within five (5) feet thereof" from paragraphs B & C in Section 13.1.8, and also paragraphs B & C in Section 13.2.8.
- 3. <u>RRC Final Submission and Master Plan</u>: Village Council has made the additions to the website that were needed. Alex Hritku from ROWE emailed the corrected maps, and he will put together the Resolution and zoning amendments for the website also. The requirements for the website, zoning ordinances, and Master Plan are finished, and M. Simon will notify Katie Higgs at MEDC of their completion.

### **New Business:**

- 1. <u>Conceptual Review at 4 S. Lake St.</u>: Dan & Natasha Sinagoga shared their plans for the property at 4 S. Lake St. They plan to demolish the building on the far west side of the property, and to power-wash and paint the white house on the east side of the property for the purpose of starting a business on the site.
- 2. <u>Training Downtown Reform</u>: M. Simon shared a handout on "Main Streets and Downtowns". It discussed how short-term and mid-term fixes to streets and downtown areas can happen with changes in zoning text amendments, street design standards, and building forms.
- 3. <u>Planning Commission Terms Expiring 6/30/24</u>: B. Dear, R. Emond, and E. Bruss terms will expire on June 30, 2024. B. Dear and R. Emond are not seeking reappointment to the Planning Commission. E. Bruss will let the village clerk know his intentions in writing.
